Dear Parents, Guardians and Students in Year 9 English Acquisition,

**RE: MYP3 English Acquisition Summative Task Field Trip**

This is to inform you that Year 9/MYP 3 English Acquisition students will be going on a field trip on Monday, 7th January, 2019.

The trip will be a hiking and nature center exploration in the Bukit Timah Nature Reserve. This is to collect the information and photos necessary for a summative travel writing task in Term 3. This summative task allows students to gather descriptive data, to collect environmental and tourist information from the visitor center, and to research nearby dining and transportation options for their travel writing piece.

I am enclosing a consent form. Due to the upcoming winter break, please sign and return the form to school by Monday, 10th December. The only cost involved for the field trip is the MRT ride from Beauty World station to Sixth Avenue station, where students will take the Chatsworth shuttle bus back to campus. Your child needs to bring a valid topped-up MRT pass.

We will be leaving the school on foot from at 11:15 am and will be entering the Bukit Timah Nature Reserve near campus, hiking on the Kampong Trail to arrive at the Visitor Center. I will personally be accompanying the students. Students need to carry water bottles, cap, sunglasses, umbrella, sunscreen and some money for their lunch. In case of dangerous weather (lightning), the trip will be postponed.

We will return from Beauty World station to Sixth Avenue station by MRT, where the students will be dismissed at 3:30 p.m. Please let me know if there are any queries or clarifications required.
