RE: MYP5 Individuals and Societies field trip to the Singapore Urban Redevelopment Authority and Chinatown on Friday 6th September, 2019

Dear Parents and Guardians of MYP5 students,

As part of the students' unit on urbanisation we will be visiting Singapore City Gallery to investigate the Urban Redevelopment Authority exhibition on Friday 6th September at 9:00 AM. Entry cost to the museum is free.

We will continue the field trip by walking to Chinatown MRT where students will conduct research into urban landscape theory. Students will be walking from the CBD to Chinatown, so they are encouraged to bring a hat and sunscreen - although most of the walk will be shaded. This research will form a part of their assessment, so it is vital that they are available to attend this field trip. More details on this assessment will be posted to Managebac in due course.

Our goal is to have the students see urban planning principles in practice, consider how urban planning impacts the lives of people, and to complete a research assessment task which analyses and presents data to make conclusions about how Singapore has changed over the last 53 years.

All students will meet at Chinatown MRT at 9:00am for attendance. Students should go directly to the MRT, to maximize our time on the field trip. The Urban Redevelopment Authority is located near to Chinatown and we will travel as a group from the MRT. We will dismiss class at 3:30pm from the MRT, again, to maximize our time on the field trip. Students will gather together for lunch at the Chinatown food centre where they can purchase food, or eat a packed lunch.
