**RE: TOK Field Trip to the City Harvest Church**

Dear students, parents/guardians of Mr. Newberry's DP1 TOK class,

As part of our new unit on Religious Knowledge Systems, students will be looking at different religious traditions and how the act of religious worship contributes/aids in the religious experience. Given that there are a few "megachurches" in Singapore, it would be valuable to see how one of the larger religious traditions here conducts their services and how they address the question of religious experience in their ministry.

After approaching a few churches, we were happy to receive a reply from the City Harvest Church who will be conducting a short tour of their facilities, as well as answering some of the following questions:

- \* Is there an overarching "mission" of the church?
- \* What makes CHC different in their mission from other churches in Singapore?
- \* How does the facility aid in the religious experience CHC wants to have at their services?
- \* What is the role of young people in CHC?

A representative of CHC will also be answering any questions the students have and the entire trip (including travel time) should take no more than an hour and a half. **The excursion will take place on Thursday April 18th, which is this Thursday.** Students will be leaving the Bukit Timah campus at approximately 11am and return for lunch. The cost of the field trip is \$14 per student.
